Law 27557

Law No. 23968. Amendment.

The Senate and the Chamber of Deputies of the Argentine Nation, in Congress assembled, etc., enact the following with the force of law:

Article 1 – The paragraph below is incorporated as the second paragraph of article 6 of law No. 23968 on Maritime Spaces:

The outer limit of the Argentine Continental Shelf (continental and insular sectors) is demarcated, according to the points of geographic coordinates set out in ANNEX III hereto.

Article 2 – Points RA-01 to RA-481 and RA-3458 to RA-3840 of ANNEX III referred to in article 1, and attached hereto, are demarcated on the basis of the Recommendations of the Commission on the Limits of the Continental Shelf (CLCS), in terms of article 76 paragraph 8) of the United Nations Convention on the Law of the Sea of 10 December 1982.

Points RA-482 to RA-3457 of ANNEX III referred to in article 1, and attached hereto, are demarcated on the basis of the Argentine submission to the Commission on the Limits of the Continental Shelf (CLCS), pending Recommendations in terms of item 5.a of Annex I to the Rules of Procedure of the Commission.

Points RA-3841 to RA-6336 of the continental shelf corresponding to the Argentine Antarctic Sector, referred to in the Argentine submission to the Commission on the Limits of the Continental Shelf (CLCS), are comprised within the situation defined in article 1, third paragraph of law No. 23968 on Maritime Spaces.

Article 3 – This measure shall enter into force on the day following its publication on the Official Gazette of the Argentine Republic.

Article 4 – Let it be notified to the national Executive Power.
